Agreement on Co-operation for Medical Value Travel (MVT) between the Ministry of Health & Family Welfare of the Republic of India and the Ministry of Health and Prevention, Government of United Arab Emirates

Preamble

The Ministry of Health & Family Welfare of the Republic of India and the Ministry of Health and Prevention of the Government of United Arab Emirates, hereinafter referred to as the Parties;

Desiring to enhance co-operation on boosting Medical Value Travel (MVT) for increased patient inflows to India and ensuring sustainable long-term growth of the sector between the two countries

Recognizing that this Agreement will enable both Parties towards a comprehensive Healthcare co-operation Agreement have agreed as follows:

Article 1

Parties to the Agreement

Parties of the Agreement are:

First Party: Ministry of Health and Prevention of the Government of United Arab Emirates

Second Party: Ministry of Health & Family Welfare of the Republic of India.

Article 2

Objective of the Agreement

This Agreement aims to enhance the co-operation on boosting Medical Value Travel (MVT) for increased patient inflows to India and ensuring sustainable long-term growth of the sector between the two countries.

Article 6

Settlement of Disputes

Any disputes arising out of interpretation and implementation of this Agreement shall be settled by both Parties amicably through diplomatic channels.

Article 7

Amendments to the Agreement

Any amendment or revisions to any provisions of this Agreement shall be done by mutual consent and shall take effect on the date agreed upon by the Parties.

Article 8

Entry into force

Each Party shall notify the other Party in writing through the diplomatic channels of completion of required domestic legal procedures. This Agreement shall be effective as of the date of the latter notification thereof.

Article 9

Validity and duration

- (i) This Agreement shall be valid for XX years and shall be renewable for a similar period(s), unless either Party officially notifies the other Party in writing of its intent to suspend or terminate the Agreement two months prior to the expiry date of this Agreement.
- (ii) Notwithstanding termination of this Agreement, its provisions shall remain in force with regard to Agreement and contracts conduced during validity of this Agreement.

This Agreement is done in the City of New Delhi on XX, 20XX, corresponding to XXXYYZZ H, in two originals; English, Hindi and Arabic, all texts being equally authentic, and in case of diverge in interpretation, the English shall prevail.
